FINAL POST-JUDGMENT REPORT AND ACCOUNTING OF RECEIVER BRIAN A. MCDOWELL

(covering the period from June 30, 2018 through December 14, 2018)

Brian A. McDowell, as Permanent Receiver ("Receiver") of J. William Enterprises, LLC ("JWE") and Pro Timeshare Resales of Flagler Beach, LLC ("Pro Timeshare Flagler") (JWE and Pro Timeshare Flagler are collectively referred to as the "Receivership Defendants"), and pursuant to this Court's Stipulated Final Judgment and Order dated April

30, 2018 (Doc. No. 214), by and through his undersigned counsel, files this Final Post-Judgment Report and Accounting of Receiver ("Report").

I. <u>ACCOUNTS, RECEIPTS, AND DISBURSEMENTS.</u>

The Receiver's total receipts to date and disbursements for the period of June 30, 2018, through December 14, 2018, are as follows:

Total Receipts: \$ 3,226,712.48

Disbursements from all Prior

Periods: \$ 475,988.80

Disbursements for Period of June 30, 2018 through

December 14, 2018: \$ 290,118.10

Current Balance: \$ 2,460,605.58

An itemization of disbursements, expenses, and interest income for the period covered by this Report is attached as **Exhibit A**. 1

II. RECEIVER'S ACTIVITIES

Since the filing of the First Post-Judgment Report and Accounting of Receiver Brian A. McDowell on June 29, 2018 (Doc. No. 217), the Receiver and his counsel worked with auctioneer Robert Ewald of Ewald Auctions to take possession of and liquidate those assets identified on Appendix A of the Final Judgment (the "Assets"). As reflected in the Auctioneer's Affidavit attached hereto as **Exhibit B**, the auction campaign produced 272

phone inquiries, 253,642 impressions on various websites, and 10,082 web views of the auction catalog, resulting in 230 registered bidders. Mr. Ewald conducted two auctions, one held on Friday, October 19, 2018 at the Receivership Defendants' prior Deland office, and the other held on October 20, 2018 at the prior residence of Defendant Jess Kinmont. All of the Assets² were sold through the auctions, and as of the date of this Report, all sales of real and personal property have closed. Further, all costs related to the Auctions have been paid. The net yield to the Receivership Estate from the Auctions was \$736,648.92.

As of the date of this Report, the Receivership Accounts have a balance of \$2,460,605.58. Two checks³ in the combined amount of \$3,872.00 have been issued from the Receivership Accounts, but have not yet been cashed. The Receiver anticipates that he will receive a utility deposit refund⁴ in the amount of \$166.17 on or around the week of December 17, 2018, and an interest credit of approximately \$1,700.00 on or around December 31, 2018.

The Receiver has fully wound-down the affairs of the Receivership Defendants, and contemporaneous with the filing of this Final Report, he will file a motion requesting the entry of an order discharging the receiver pursuant to the terms stated therein.⁵ The

³ Check No. 285, issued on November 27, 2018, was made payable to Hostek.com in the amount of \$72.00 for e-mail storage services. Check No. 287, issued on November 28, 2018, was made payable to Department of Legal Affairs, Escrow Account (Office of the Florida Attorney General) ("Office") in the amount of \$3,800.00, such amount representing proceeds to the Office from the sale of one piano and two statues at the Auction pursuant to an agreement between the Receiver and the Office.

⁵ To the extent necessary, and consistent with terms of the Final Judgment, the Receiver will provide Plaintiff's counsel with any additional information related to the customers of the Receivership Defendants.

Receiver is coordinating with Plaintiff to transfer \$2,300,000.00 to Plaintiff, and has withheld a reasonable sum to satisfy payment of his and his counsel's fees and expenses ("Fees and Expenses"), as well as to satisfy other possible contingencies. Following the approval and payment of the Receiver's Fees and Expenses, clearance of the two checks referenced above (or replacement checks, as appropriate), and deposit of the expected sums, the Receiver will transfer to Plaintiff any amounts remaining in the Receivership Accounts.
